Issue 1: Should the Commission impose a \$500 fine or cancel the pay telephone certificates issued to each company listed on page 5 of staff's December 22, 1998 memorandum for apparent violation of Rule 25-4.0161, Florida Administrative Code, Regulatory Assessment Fees; Telecommunications Companies?


Recommendation: Yes. The Commission should impose a \$500 fine or cancel each company's certificate listed on page 5 if the fine and the regulatory assessment fees, including statutory penalties and interest, are not received by the Commission within five business days after the conclusion of the 21-day protest period. The fine should be paid to the Florida



If the Commission's Order is not protested and the fine and regulatory assessment fees, including statutory penalties and interest, are not received, the pay telephone certificates listed on page 5 should be canceled with an effective date of December 31, 1998.
