

In Order No. PSC-95-0783-FOF-EC issued on June 29, 1995, in Docket No. 950333-EC the Commission approved the territorial agreement entered into by and between Clay Electric Cooperative, Inc. and Sumter Electric Cooperative, Inc. Section 5.2 of said Agreement calls for an annual report from Clay Electric Cooperative, Inc. providing the status of the Agreement and any modifications proposed in the Agreement.
