3. The FCCA is a telecommunications industry organization whose primary purpose is to promote and foster competition in Florida. FCCA members provide telecommunications services in Florida in BellSouth Telecommunications, Inc.'s (BellSouth) service territory through various methods, including the resale of BellSouth services.

4. BellSouth has filed a promotional tariff called "3 Free." This tariff, if permitted to take effect, would allow BellSouth to target customers who have left BellSouth for a competitive carrier and attempt to recapture such customers by offering them 90 days free service in exchange for signing an 18-month contract with BellSouth. 

(Arrow) filed a petition to review and cancel the tariff. In this docket, the Commission will process Arrow's complaint and determine whether BellSouth's tariff offering is discriminatory, anticompetitive and constitutes predatory pricing

5. FCCA members compete for customers with BellSouth in Florida. Their ability to retain customers who have chosen them over BellSouth will be detrimentally harmed if the proposed tariff is allowed to take effect. Therefore, FCCA's substantial interests will be affected by the Commission's decision on the "3 Free" tariff in this docket.

WHEREFORE, FCCA requests that its petition to intervene be granted and that it be accorded full party status in this case.
