Re: Approval of the Collocation Amendment Negotiated by BellSouth Telecommunications, Inc. ("BellSouth") and KMC Telecom II, Inc. pursuant to Section 252(e) of the Telecommunications Act of 1996

Dear Mrs. Bayo:

Pursuant to section 252(e) of the Telecommunications Act of 1996, BellSouth and KMC Telecom II, Inc. are submitting to the Florida Public Service Commission their negotiated amendment for collocation. The Commission approved the initial agreement between the companies in Order No. PSC-98-0990-FOF-TP issued July 20, 1998 in Docket 980482-TP.

Pursuant to section 252(e) of the Act, the Commission is charged with approving or rejecting the collocation amendment between BellSouth and KMC Telecom II, Inc. within 90 days of its submission. The Commission may only reject such an amendment if it finds that the amendment or any portion of the amendment discriminates against a telecommunications carrier not a party to the amendment or the implementation of the amendment or any portion of the amendment is not consistent with the public interest, convenience and necessity. Both parties represent that neither of these reasons exist as to the amendment they have negotiated and therefore, are very hopeful that the Commission shall approve their amendment.

Pursuant to this Agreement (the "Amendment") KMC Telecom II, Inc. ("KMC II") and BellSouth Telecommunications, Inc., ("BellSouth") hereinafter referred to collectively as the "Parties" hereby agree to amend that certain Agreement between KMC Telecom and BellSouth dated March 12, 1997 ("Physical Collocation Agreement"). BellSouth is currently providing service to KMC Telecom II under the terms of this Physical Collocation Agreement.


NOW, THEREFORE, in consideration of the mutual agreements and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties hereto agree as follows:

1. The Parties agree that BellSouth will, upon request, provide and KMC II will accept and pay for Acceptance of Fiber Cross-Connects and Fiber POT Bay in accordance with the schedule of prices set forth in Attachment A to this Amendment which is incorporated herein by reference.
2. The Parties agree that all of the other provisions of the Agreement, dated March 12, 1997, together with all amendments in effect as of the date of execution of this Amendment shall remain in full force and effect.
3. The Parties agree that either or both of the Parties is authorized to submit this Amendment to the Public Service Commission or other regulatory body having jurisdiction over the subject matter of this Amendment, for approval subject to Section 252(e) of the federal Telecommunications Act of 1996.
