By letter dated February 1, 1999, United Water Florida Inc. requested a deferral of this item from the Agenda. The utility has requested a deferral until the February 16, 1999 Agenda Conference and submitted a waiver of the 5-month statutory deadline contained in Section 367.081(8), Florida Statutes until that date. The utility has found a problem with staff's growth projection which may have a material effect upon the revenue requirement. Since the utility has agreed to waive the 5-month statutory deadline, staff agrees that this deferral should be granted.


Dear Mr. Willis:
