## Channel.

- (5) This rate element is for use in those states with a different rate for additional minutes of use.
- (6) BellSouth and CLEC shall negotiate rates for this offering. If agreement is not reached within sixty (60) days of the Effective Date, either party may petition the Florida PSC to settle the disputed charge or charges.
- (7) This rate element is for those states w/o separate rates for 300 calls with 800 No. Delivery vs. POTS No. Delivery and calls with Optional Complex Features vs. w/o Optional Complex Features.
- (8) This charge is only applicable where signaling usage measurement or billing capability does not exist.
- (9) Rates for access to Poles, Ducts, Conduits and Rights-of-Way are negotiated with BellSouth's Competitive Structure Provisioning Center.
