Dear Ms. Bayo:

In reference to Ms. Draper's memorandum dated February 1, 1999, Florida Power and Light Company (FPL) submits the following revised report in accordance with Chapter 25-6.018 of the Florida Administrative Code. The report addresses the interruptions of FPL's Commercial/Industrial Load Control (CILC), Interruptible Standby and Supplemental (ISST), and Curtailable (CS) customers' load. The report includes three attachments, described below. The attachments contain the names of governmental customers interrupted for each of the times in question.

Attachment I provides a list of CILC and ISST governmental customers interrupted system wide in June in order to offset heavy power demands and a capacity shortage resulting from hot weather. The control period was as follows:


