

On June 19, 1998, AT&T Communications of the Southern States, Inc. (hereinafter "AT&T"), by and through its undersigned attorney, filed a Petition asking the Florida Public Service Commission to modify BellSouth Telecommunications, Inc.'s policies on porting Direct-In-Dial numbers. On December 17, 1998, BellSouth revised its tariff to allow the porting of numbers in blocks of less than 20 numbers, as well as the porting of non-consecutive numbers. Pursuant to Rule 25-22.035(3), Florida Administrative Code and Rule 1.420(a)(1), Florida Rules of Civil Procedure, AT&T hereby files this Notice of Voluntary Dismissal of its petition in the instant docket without prejudice.


