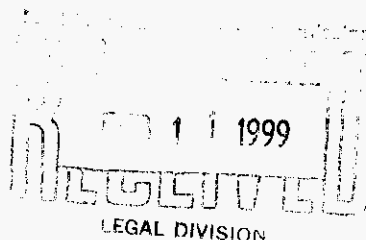
Please reschedule the audit review for a time after such annual reports are completed and filed with the Commission.
