After I had returned from the Agenda Conference on February 2, 1999, I received the attached letter from the company's general counsel. Order No. PSC-99-0329-FOF-TI was issued February 19, 1999, which ordered the company to pay a \$500 fine plus past due regulatory assessment fees, along with statutory penalty and interest charges. Since the company has paid the 1997 and 1998 regulatory assessment fees and made a settlement offer, staff needs to take this back to Agenda. Dear Commission and Ms. Isler:


