NARRATIVE OF SERVICE ENVIRONMENT AND FACTORS  
LEADING TO PROPOSED DEPRECIATION RATES, AND  
EXPLANATION FOR CATEGORIES OF DEPRECIABLE PLANT

Pursuant to Rule 25-7.045, Florida Administrative Code, City Gas Company of Florida, a Division of NUI Corporation (NUI/City Gas or the Company), is filing this depreciation study for approval of a change in its depreciation rates to be implemented as of January 1, 1999. The Company last filed a depreciation study in February, 1994.

NUI/City Gas is a natural gas distribution company engaged in distributing and transporting natural gas to approximately 100,000 consumers in Dade, Broward, Martin, St. Lucie, Indian River, and Brevard counties within the State of Florida.

Much change has occurred within NUI/City Gas since its last depreciation study:

- The Company built a new natural gas distribution system and initiated service in Vero Beach, and surrounding Indian River County, Florida.
- The Company aggressively expanded its distribution system in Port St. Lucie, Florida, with the purchase and conversion to natural gas, of an underground propane system serving over 1,000 customers. This purchase was recorded in December 1998.
- The Company has purchased facilities from Ft. Pierce Utility Authority, Western Energy, and Consolidated Gas, and incorporated them into City Gas Company's natural gas distribution system.
- The Company expanded its Brevard County distribution system and, at the urging of the Florida Public Service Commission Staff, started construction of a Brevard system loop, designed to eliminate low pressure problems in the Brevard system.
- Leased appliances were removed from the regulated assets of the utility per the Florida Public Service Commission's 1995 Order on the Company's request for a rate increase.
- In 1997, the Company sold its Medley warehouse, and now leases warehouse space.

- At the direction of Commission Staff, the Company implemented an aggressive cut and cap program for discontinued natural gas services, as well as a galvanized pipe replacement program.
- Since the last depreciation study, NUI/City Gas has gone from local management, to NUI Southern Division management, to NUI Corporate management. In that time, most management responsibilities, including gas supply, billing, legal and regulatory affairs, risk management, most accounting functions, financing, and human resources, have been transferred from local management, to NUI Southern Division, to NUI Corporate management.

Since 1993, gross utility plant in service has increased from \$103 million to \$146 million. The Company has achieved a 6.3 % increase in its average number of customers. The Company expects positive growth to continue into the future.

As noted above, the accounting function for City Gas is now substantially centralized in New Jersey. Over the course of the last two years, there has been an exhaustive effort put forth by NUI staff, both in New Jersey and Florida, to accomplish the following objectives:

- 1) assure a smooth transition of City Gas plant accounting from Florida to New Jersey.
- 2) convert City Gas plant accounting records from a manual to an automated/integrated system.
- 3) age all assets and related units by vintage year so as to provide a means to retire such assets at the average cost for the year placed in service, as opposed to the company's past practice of using average unit costs from ten years prior for retirement of mass assets. The specific methodology employed to arrive at this vintage year information is discussed below for each class affected. Where historical data was readily available, it was used. Where such data was not readily available, certain assumptions and estimates of costs by vintage year were used, in accordance with FPSC Rule 25-7.0461.

Throughout this period, management has made a substantial effort to improve and automate the process for accounting for its assets. Management recognizes that much work remains to improve the level of quality and reliability of this data. Management is committed to the further improvement of its asset accounting.

The Company provides the following narrative explanation for each category of depreciable plant:

Account 375 - Structures and Improvements - The sale of the Medley warehouse took place in 1997. Also, since the last depreciation study, the City Gas Hialeah offices have been moved from City Gas, to NUI Southern Division (from 1995 to 1998), and back to City Gas. With the elimination of NUI's Southern Division in 1998, NUI's operating divisions in Maryland, Pennsylvania, and New York, are now managed out of NUI's Corporate headquarters in New Jersey, and not out of Hialeah.

Account 376 - Mains - Other Than Plastic - The Company's galvanized replacement program resulted in the replacement of galvanized iron with plastic pipe and the retirement of the galvanized iron on the Company's books.

Any retirements of mains within this five-year period (1994-1998) that were calculated using a prior-ten-year average cost basis were reversed and then recorded using the specific average cost of the year the main was placed in service. If the placed-in-service date was not available, the oldest vintage year was used. If there was insufficient footage remaining, cost data for the closest year was used.

Account 376 - Mains - Plastic - The majority of the pipe being installed in the Company's system is plastic. There has also been significant expansion in Vero Beach, Port St. Lucie, and Brevard County.

Also, see discussion above in "Account 376 - Mains Other than Plastic" relating to retirements.

Account 379 - Measuring and Regulating Station Equipment - The Company's two new gate stations at Vero Beach, and one at Cutler Ridge, will impact this account.

Account 380 - Services - Other Than Plastic - Galvanized iron replacement will impact this account, as will retirements resulting from cut and caps.

Also, see discussion above in "Account 376 - Mains Other than Plastic" relating to retirements, as services were handled in a similar manner.

Account 380 - Services - Plastic - The majority of new services being installed are plastic. Cut and caps have resulted in the retirement of some plastic services.

Also, see discussion above in "Account 376 - Mains Other than Plastic" relating to retirements, as services were handled in a similar manner.

Account 381 - Meters - The Company has aged and priced meters using information from its Meter Management System and cost data from the plant ledger. The number of outstanding meters was determined using a current meter management report which provides a count of meters by size and year. Wherever actual information was available from the plant ledger (cost, size, quantity) it was used in calculating the average cost for that year. If the unit cost could not be determined using the plant ledger, an estimate was used based on actual cost information for the closest year available, adjusted slightly for inflationary factors. The estimated total cost was then determined by multiplying the number of meters by the unit cost for each size of meter for each vintage year.

Once the calculations were performed, a total cost for meters was derived and compared to the general ledger total. As anticipated, because of the use of certain estimates and assumptions in the methodology employed, a slight difference existed between the calculated costs and the general ledger total (less than 5%). Accordingly, the calculated costs were adjusted on a pro rata basis to agree to the general ledger. From that point forward (June, 1996), meters were retired by type and average cost for the vintage year purchased

Account 381 - Transponders - The Company has aged and priced transponders using information from the manual plant ledger.

Account 382 - Meter Installations - The Company aged and priced meter installations using information from the plant ledger. The Company used actual average installations costs for current years, and then used these costs to derive prior years' costs using flat inflationary factors. The estimated total installation cost was then determined by multiplying the number of meters in service for each classification by the installation cost per meter for each respective year. Retirements of meter installations followed the methodology described above for Account 381 - Meters.

Account 383 - House Regulators - The Company has aged and priced regulators using information from the Meter Management System and cost data from the plant ledger (See discussion for "Account 381 - Meters", above). The number of outstanding regulators was determined by using the meter management system report, which provides a count of meters by size and year, and matching regulator types with corresponding meter types. The average cost per regulator was determined by taking the latest actual total cost and dividing by the number of regulators purchased. If the unit cost could not be determined, an estimate was used. The estimated total cost was then determined by multiplying the number of regulators by size, by the unit cost per regulator for each respective year.

Once the calculations were performed, a total cost for regulators was derived and compared to the general ledger total. As anticipated, because of the

use of certain estimates and assumptions in the methodology employed, a difference existed between the calculated costs and the general ledger total. Accordingly, the calculated costs were adjusted on a pro rata basis to agree to the general ledger.

Retirements of regulators were handled in a similar fashion to meters, as described in Account 381 above.

Account 384 -House Regulator Installations - The Company has aged and priced house regulator installations using the same methodology as for meter installations, described above in Account 382.

Account 386.5, 386.6, and 386.7 - Leased Water Heaters, Leased Dryers, and Leased Ranges - These accounts have been eliminated since the Company's last depreciation study, since they are no longer regulated assets of the utility per Commission Order.

Account 387 - Other Equipment - We know of no major changes that have affected this account.

Account 390 - Structures and Improvements - The Company's sale of the Medley warehouse will have an impact on this account.

Account 391.1 - Office Furniture - We know of no major changes that have affected this account.

Account 391.2 - Office Equipment - We know of no major changes that have affected this account.

Account 391.3 - Computers - The Company's expenditures on its SCADA engineering and mapping system will impact this account.

Account 392 - Transportation Equipment - We know of no major changes that have affected this account.

Account 393 - Stores Equipment - We know of no major changes that have affected this account.

Account 394 - Tools, Shop, and Garage Equipment - We know of no major changes that have affected this account.

Account 395- Laboratory Equipment - We know of no major changes that have affected this account.

Account 397 - Communications Equipment - Major upgrades to the telephone system will impact this account.
