Re: Approval of an Amendment to the Interconnection Agreement Negotiated by BellSouth Telecommunications, Inc. ("BellSouth") and Time Warner Communications pursuant to Sections 251, 252 and 271 of the Telecommunications Act of 1996 TX 000

Dear Mrs. Bayo:

Pursuant to section 252(e) of the Telecommunications Act of 1996, BellSouth and Time Warner Communications are submitting to the Florida Public Service Commission an amendment to their negotiated agreement for the interconnection of their networks, the unbundling of specific network elements offered by BellSouth and the resale of BellSouth's telecommunications services to Time Warner Communications. The Commission approved the initial agreement between the companies in Order No. PSC-96-1215-FOF-TP issued September 24, 1996 in Docket 960719-TP.

Pursuant to section 252(e) of the Act, the Commission is charged with approving or rejecting the negotiated agreement between BellSouth and Time Warner Communications within 90 days of its submission. The Act provides that the Commission may only reject such an agreement if it finds that the agreement or any portion of the agreement discriminates against a telecommunications carrier not a party to the agreement or the implementation of the agreement or any portion of the agreement is not consistent with the public interest, convenience and necessity. Both parties aver that neither of these reasons exist as to the agreement they have negotiated and therefore, are very hopeful that the Commission shall approve their agreement.

7th AMENDMENT TO AGREEMENT BETWEEN
TIME WARNER COMMUNICATIONS AND
BELLSOUTH TELECOMMUNICATIONS, INC.
DATED JUNE 6, 1996

Pursuant to this Agreement (the "Amendment"), Time Warner Communications ("Time Warner") and BellSouth Telecommunications, Inc. ("BellSouth") hereinafter referred to collectively as the "Parties" hereby agree to amend that certain Interconnection Agreement between the Parties dated June 6, 1996 ("Interconnection Agreement").

NOW THEREFORE, in consideration of the mutual provisions contained herein and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Time Warner and BellSouth hereby covenant and agree as follows:

1. Effective January 25, 1999, the retail charges for Automatic Intercept Service (AIS) Digital ESSX in the state of North Carolina are as provided in Exhibit 1, incorporated herein by this reference.
2. The Parties further agree that either or both of the Parties is authorized to submit this Amendment to the North Carolina Public Service Commission or other regulatory body having jurisdiction over subject matter of this Amendment, for approval subject to Section 252(e) of the federal Telecommunications Act of 1996.
3. The Parties further agree that the terms of the existing Agreement is two years beginning June 6, 1996. This Amendment is in effect only for remaining months of the existing Agreement.
