ESCROW AGREMMENT

THIS ESCHOW AGRERMENT is made by and between The Hunting fon National Book in Pasco County (the Dank), the Flurida Public Service Commission (FLORIDA PUBLIC SERVICE COMMISSION), and Disc Groves, (the Utility), a Florida Commission, upon the following terms, conditions, and considerations:

WITNESSETH

WHEREAS, by Order No. SC-99-0243-FoF-WH issued 2-9-99, the FIORIDA PUBLIC DENVICE. COMMISSION authorized the Utility to continue to collect increased rates as temporary rates and WHEREAS, by Order No. FT-98-0243-FoF-WH, the Utility is required to provide security for those temporary rates that generate per cumlomer collections in excess of those collections resulting from the application of the rates approved effective March 3,1999, and WHEREAS the Dank has agreed to hold such funds in an interest particle of 4,33 1, the parties hereto agree as follows:

- 1. The foregoing representations are true and correct.
- The Utility shall open a joint interest bearing esurow account. The amount of revenue subject to refund shall be deposited by the Utility in the escrow account within seven days of receipt.
- 3. The escrow account shall bour interest at the rate of 4.33 4.
- The FLORIDA FUBLIC SERVICE COMMISSION'S Director of the Division of Records and Reporting shall be a signatory to the escrow account.
- 5. No funds shall be withdrawn from the excrow account without the signature of both the Director of the Division of Records and Reporting of the FLOKIDA PURLIC SERVICE COMMISSION and the Utility. Signature cards oxecuted by the Director of the Division of Records and Reporting of the FLORIDA PURLIC SERVICE COMMISSION and the Utility shall designate the appropriate authorized signature for each.
- The Bank shall ferward regular monthly elements (including canceled checks) to the utility and shall mail a copy of the monthly account atatement to the FLORIDA PURITE SERVICE COMMISSION.
- 7. If a refund to the customers is required, all interest earned by the escrow account shall be distributed to those customers who poid such monies that generated the deposits into the escrow account.
- 8. If a refund to the customers is not required, the interest carned by the escrow account shall revert to the utility.
- The Bank may, without reason, withdraw from this Agreement upon thirty (30) days written notice to the FLORIUM PUBLIC SERVICE COMMISSION and to the Utility.
- 10. The Dtility shall indumnify and hold the Dank harmless from any claim, demand or loss suffered by the Bank, and the cost thoroof (including court costs and attorney fees for negotiation, trial and epimal).
- 11. While excrew account is established pursuant to FIGHIDA PUBLIC SERVICE COMMISSION Order No. PSC-77-0245-FoF-UR issued _2-9-99 . This encrew account is for the benefit of the Utility's customers.
- Information concerning the escrow account shall be evailable from the Bank to the FLORIDA PUBLIC SERVICE COMMISSION and its representatives at all times.
- This userow account is established by the direction of the Florida Public Service Commission for the purpose(s) set forth in its Order sequiring such account. Pursuent to Cosentino v. Rison, 263 Sn.2d 253 (Fig. 3rd DCA 1972), escrow accounts are not subject to garnishment.
