I am writing to confirm the Commission staff's understanding of your intent to file written settlement agreements to resolve the pending show cause proceedings against Peoples Telephone Company, Inc. and Telaleasing Enterprises, Inc. It is our understanding that both companies intend to file proposals with the Commission on or before March 18, 1999. This understanding formed the basis for staff's support of the Commission's deferral of the February 4, 1999, recommendation to show cause the companies from the February 16, 1999, Agenda Conference to the March 30, 1999, Agenda Conference.
