This letter is in response to John Williams' letter of
February 12, 1999, requesting that we file with you additional
information regarding the above-referenced Application. That
information is as follows:

◆ Evidence Utility Owns the Land. Ocala Oaks Utilities,
Inc. has begun the title examination in order to issue title
insurance policies on the three properties which were acquired by
Quit Claim Deed. We expect those title policies to be available by
the end of next week and will file them with you upon receipt.

◆ Closing. AquaSource Utility, Inc. and Ocala Oaks
Utilities, Inc. do not contemplate closing this sale prior to
Commission approval.

◆ Typographical error. There was apparently a
typographical error in the legal description in the Commission
Order describing the service area for Woodland Place subdivision.
The Order placed that subdivision in Township 15 South, instead of
the correct Township, which is 14 South. Otherwise, the metes and
