Dear Mr. Salsano:

We have reviewed your letter of March 4, 1999, regarding the proposed agreement with the City of Altamonte Springs. It appears that the joint reuse concept contemplates that the utility will convert to 100% reuse and thereby eliminate surface water discharge, which would benefit the utility, the utility customers, the City of Altamonte Springs, and ultimately the State of Florida. What we do not have, and will need in order to process the utility's application, is the means by which that goal can be achieved. Have any engineering drawings been completed? What timeframe can we expect for estimated costs? What effect will this new proposal have on the utility's current filing in the above docket?

Staff is presently operating under a statutorily imposed timeclock. A recommendation for Sanlando's current filing is scheduled to be filed April 8, 1999, for consideration by the Commission at the April 20, 1999, agenda conference, as the utility has waived the five month deadline through the end of April, 1999. Do you plan to extend this deadline to allow time for the consideration of this new proposal? Do you plan to request that the five-month timeclock be reset due to the proposed major changes to the existing filing, or do you anticipate filing a new reuse application and withdrawing the current filing? Please advise us as soon as possible.
