This is a follow up to our March 12 telephone conversation concerning your client. It was my understanding that ConnectOne wishes to cancel its IXC certificate in Florida. Since that is the case, you need to respond to Order No. PSC-99-0397-FOF-TI, by stating ConnectOne wishes to cancel its certificate and pay the past due charges. The company owes the 1997 and 1998 regulatory assessment fees (RAPs), including statutory penalty and interest charges. The minimum amount past due for the 1997 RAPs currently amounts to \$70.00 (\$50.00 RAP, \$12.50 penalty, and \$7.50 interest) and \$54.00 (\$50.00 RAP, \$3.00 penalty, and \$1.00 interest), or a total of \$124.00. Please note that the interest charge for both years increases each month that the fees remain unpaid. The amounts above are for payments in March 1999.

Rule 25-24.474(2)(a),(b),(c),and (d), Florida Administrative Code, states:

- (2) If a certificated company desires to cancel its certificate, it shall request cancellation from the Commission in writing and shall provide the following with its request:
- (a) Statement of intent and date to pay Regulatory Assessment Fee.
  - (b) Statement of why the certificate is proposed to be cancelled.
  - (c) A statement on treatment of customer deposits and final bills.
  - (d) Proof of individual customer notice regarding discontinuance of service.

Your response to the Order should be address<sup>ed</sup> to Ms. Blanca Bayo, Director, Division of Records and Reporting, at the above address and must be received by March 17, 1999. If payment of the fees is not included with your letter, then you must provide a date certain that the fees will be paid. Otherwise, the Order becomes final and the \$500 fine assessed.
