Protests were due 3/11/99. We received the following filing on 3/22. Do we need to reopen docket to handle payment of fine?

(Forgot to include the filing!! Here it is:)

ADM/FISCAL - Copy of \$750 check from Network Access for payment of fine and past due RAFs; Deposit D108 dated 3/22/99.

I need to send RAR a memo closing the docket and a king that the certificate not be canceled.

The docket was closed and certificate canceled effective 3/19/99 because a timely response was not received in response to the PAA order (that included the extra five days following PAA expiration date.) SO, I guess my question should have been, reopen to reactivate certificate?

My notes indicate that on 3/12, Jackie Knight called me at 8:45 a.m. and said she had received the fine and RAFs payment. They sent me a copy of what the company had sent and it is date-stamped 3/11/99, which was timely. Since it was received timely (Admin just did not send proof until after the docket was closed), does this mean that we need to reopen the docket? I'll do whatever you suggest. Thanks.

Sandy, after rereading everything, I believe that the answer to your question is yes. We do need to reopen the docket to reactivate the certificate. My question is: do you want me to send you a memo like I did on some of the other cases where I asked that you reopened a case? Just let me know.

Since the protest was timely, the certificate should not have been canceled, (Fiscal really should send us immediate proof of compliance!) so we can reactivate it without reopening the docket. However, I would like for you to put all of the information in your previous e-mail in the memo and we'll change the closed date and Nonnye will take care of the reactivation in MCD.
