

## **MOTION FOR EXTENSION OF TIME**

**COMES NOW** Manatee County, Florida, a political subdivision of the State of Florida, by and through its undersigned counsel, and hereby requests that it be granted an extension of time within which to file its pre-filed testimony in the above-referenced docket. In support hereof, movant states as follows:

- 1. Pursuant to the Case Assignment and Scheduling Record (CASR) for this docket, the filing date for pre-filed direct testimony was Thursday, March 18, 1999.
- 2. This docket was opened on March 1, 1999 as a result of a formal complaint being filed by Cellular One.
- 3. On March 30, 1999, the Manatee County Board of County Commissioners . . . directing its attorneys to seek to intervene in this proceeding for the purpose of presenting Manatee County's position that the 941 area code should be retained by Manatee County.
- 4. The Office of County Attorney was not notified of the pending proceeding until March 29, 1999, and therefore could not obtain direction from its Board until that date. Since receipt of notice, diligent attempts to contact necessary organizations and individuals for pre-filed testimony have been made.
- 5. Manatee County will be able to file its pre-filed testimony in this docket no later than Monday, April 5, 1999.
- 6. Manatee County's pre-filed testimony will address impacts of the proposed area code change on governmental and community interests.

**WHEREFORE**, for the reasons hereinabove stated, Manatee County, Florida, respectfully requests that the Commission grant Manatee County an extension of time to April 5, 1999, to file its pre-filed testimony in Docket No. 99-0223.
