Dear Mr. Mears:

Your response on behalf of S. V. Utilities, Ltd. (SV) for additional information was received by the Commission on January 8, 1999. Staff has preliminarily reviewed the response and the revised territory maps, and has determined that one of the maps does not agree with the territory description. First keep in mind, the revised maps that were submitted were not labeled by Docket or system. We still have questions about the Hidden Cove East system. See Attachment A for our territory description. According to the revised map, the 25 foot buffer zone is not included in the territory description. However, if the buffer zone is, this would explain the difference in our measurements. Please confirm that the buffer zone should or should not be included in the territory description. If the buffer zone is not included, our first measurement difference is the 165 feet the utility reported vs our 200 feet distance. We obtained our measurement by adding 52 feet plus (lot)  $\mp$  40 feet (road) + 82 feet (lot) + 25 feet (buffer zone) + 1 foot rounding = 200 feet. Please see Attachment A, our legal description, and Attachment B, our map. If your description is correct, provide a map that shows your distances are correct. Another question is the dashed line that appears to surround Hidden Cove East. We have highlighted the additional area in pink. Please confirm that this area should not be included in the legal description. It appears that at some point in time this tract was part of the parcel. DAT
