I was out of town from March 3, 1999 until March 10, 1999.

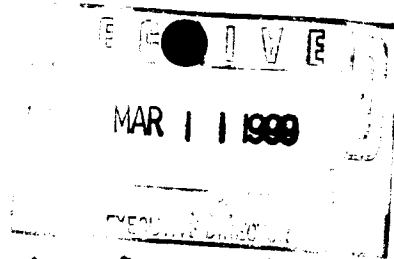
Therefore, I respectfully request a deferral of this issue because of lack of time to prepare and respond to the issues.

Although the official notification has not been received by our office, this letter is to acknowledge our awareness of the "Initiation of Show Cause" dated March 4, 1999.

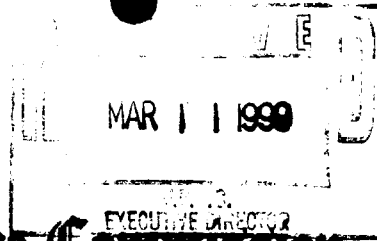

Please be advised that we are in receipt of the Staff Recommendation for the above referenced Docket, which is scheduled for consideration by the Commission at the March 16, 1999, Agenda Conference. By this written submission, made on behalf of Davel Communications, Inc. (Davel), which owns Communication Central, Inc. (the subject of Docket No. 990200-TC), a deferral of this matter until the March 20, 1999, Agenda is hereby requested.

Please also note that this matter is related integrally to two other potential show cause proceedings, Docket No. 981798-TC, concerning Teleleasing Enterprises, Inc. and Docket No. 990109-TC, concerning Peoples Telephone Company, Inc., both of which are also wholly-owned subsidiaries of Davel. These two items were deferred previously from the February 16<sup>th</sup> to March 20<sup>th</sup> Agenda Conference.

In the interest of efficiency and the preservation of resources for both the Company and the Commission, Davel intends to work towards a global resolution with the Staff and the Commission to address all of Davel related issues simultaneously and consistently. Accordingly, your assistance in obtaining the request for deferral is appreciated and will facilitate the most productive handling of these matters consistent with the public interest.

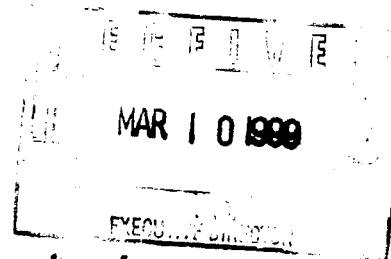
