ORDER ACKNOWLEDGING WITHDRAWAL OF
REQUEST FOR APPROVAL OF AGREEMENT

BY THE COMMISSION:

On January 8, 1999, BellSouth Telecommunications, Inc. and
Eagle Communications, Inc. filed their negotiated Interconnection
Agreement to be approved by the Florida Public Service Commission.
This Interconnection Agreement was approved at the February 16,
1999, Agenda Conference.

Subsequent to filing the original agreement with the
Commission, BellSouth filed a letter with the Commission asking to
withdraw their request for approval. BellSouth cited problems with
the copies filed with Commission, and noted that they would refile
the Interconnection Agreement at a later time. BellSouth has since
refiled the agreement, which has been assigned to Docket No.
990088-TP. Therefore, we acknowledge the withdrawal of the filing
in this original docket, Docket No. 981849, and close this docket.

ORDERED by the Florida Public Service Commission that the
withdrawal of the interconnection agreement between BellSouth
Telecommunications, Inc. and Eagle Communications, Inc., filed on



NOTICE OF FURTHER PROCEEDINGS OR JUDICIAL REVIEW

The Florida Public Service Commission is required by Section 120.569(1), Florida Statutes, to notify parties of any administrative hearing or judicial review of Commission orders that is available under Sections 120.57 or 120.68, Florida Statutes, as well as the procedures and time limits that apply. This notice should not be construed to mean all requests for an administrative hearing or judicial review will be granted or result in the relief sought.

Any party adversely affected by the Commission's final action in this matter may request: 1) reconsideration of the decision by filing a motion for reconsideration with the Director, Division of Records and Reporting, 2540 Shumard Oak Boulevard, Tallahassee, Florida 32399-0850, within fifteen (15) days of the issuance of this order in the form prescribed by Rule 25-22.060, Florida Administrative Code; or 2) judicial review in Federal district court pursuant to the Federal Telecommunications Act of 1996, 47 U.S.C. § 252(e)(6).
