BellSouth Telecommunications, Inc. ("BellSouth" or "Company") hereby files, pursuant to Rule 25-22.006, Florida Administrative Code, its Request For Specified Confidential Classification for the Slamming Data Monthly Report.

1. In a Memorandum dated October 24, 1997, the Florida Public Service Commission ("Commission"), requested BellSouth to begin reporting slamming data on a monthly basis to include the number of consumer contacts to the company related to each carrier (name & CIC), whether the slam is interLATA, intraLATA or both and the number of local slamming contacts. The above information is customer-specific.

2. BellSouth is filing this Request for Confidential Classification because the information contained in this response is clearly confidential and proprietary, and therefore, entitled to confidential classification pursuant to Sections 119.07(2)(r) and 364.183, Florida Statutes.
