Dear Ms. Bayo:

AT&T Communications of the Southern States, for itself and its affiliate AT&T Wireless Services (collectively hereinafter "AT&T"), pursuant to Section 364.183(1), Florida Statutes, hereby claims that certain information provided in response to Walter D'Haeseleer's March 22, 1999 data request for telephone number utilization contains confidential and proprietary business information that should be held exempt from public disclosure. Pursuant to Rule 25-22.006(5), in the attached envelope identified as Exhibit "A" is one copy of AT&T's response with the confidential information highlighted. Attached as Exhibit "B" are two edited copies of the same document with the confidential information redacted.

Please note that the information on the sheet identified as "AT&T Digital Link Only" does not include information for the 100 number block requests. This information is not routinely maintained by the company in this manner, and the company was unable to compile data at that level.

The information being provided also includes information for AT&T Wireless Services ("AWS"), a cellular mobile radio service provider that is not a "telecommunications company" for purposes of chapter 364, Florida Statutes. Thus, the AWS information is being provided to assist the Commission in its efforts to evaluate the status of telephone number utilization in Florida. By providing this information on a voluntary basis, AWS should not be construed as a "telecommunications company."
