 RE: Docket No. 990248-WU, Application for transfer of majority organizational control of Morningside Utility Inc., holder of Certificate No. 595-W in Osceola County, from George DeVillers to Gary K. Turner.

The Master Commission Directory shows Certificate No. 595-W assigned to "Morningside Utility Inc." without a comma between "Utility" and "Inc." This was probably due to how the application for original certificates was filed in Docket No. 970636-WU and the fact that staff never changed the error in the docket title. However, the order in that docket granting Certificate No. 595-W, Order No. PSC-97-1211-FOF-WU, ordered that the certificate be issued under the utility's recorded name of Morningside Utility, Inc. (with a comma) and that is how the certificate was issued. (Copies of the corporate screen and current certificate attached.)

Would you please see that the Master Commission Directory is corrected, and that the title in this docket is changed, to reflect the utility's currently recorded name of "Morningside Utility, Inc.?" This change will probably only be temporary as the utility may modify its name slightly as part of the transfer of majority control. Thank you.
