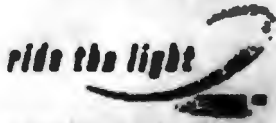

Pursuant to the provisions of Article 4.04 of the Texas Business Corporation Act, the undersigned Corporation adopts the following articles of amendment to its articles of incorporation:

ARTICLE ONE

The name of the Corporation is U.S. Long Distance, Inc.

ARTICLE TWO

On August 18, 1997, the sole shareholder of the Corporation approved an amendment to the corporation's Articles of Incorporation changing the Corporation's name to USLD Communications, Inc.

The amendment changes Article I of the Articles of Incorporation, and the full text of Article I as amended is as follows:

"The name of the Corporation is USLD COMMUNICATIONS, INC."
