



The attached Financial Statements for Internet Access and Web Services of Florida, Inc. are UNAUDITED statements prepared by an independent professional bookkeeper. In the opinion of the company they accurately reflect the financial status and operating history of the company.

Item 18 - Further written explanations

1. Internet Access and Web Services of Florida, Inc. has sufficient assets and revenues to sustain its present operations. The company has been profitable in each of the last three years and expects a significant increase in revenues and profits in 1999 due to territory expansions done early this year. The company expects to be profitable this year.

In addition, the company has a \$5,000 line of credit with First National Bank of which \$2,774 was used as of Dec. 31, 1998. The company also has credit lines, or accounts, with its major suppliers including Sprint and BankVest Leasing (\$21,101 lease currently in place).

The company proposes to operate in the following areas: Lake County, Marion County, Sumter County, Pasco County, Orange County, and Volusia County at this time. As of the date of this application, the company is operating in all the above counties. Other counties may be added in the future.

- 2. Internet Access and Web Services of Florida, Inc. has sufficient cash flow to maintain all of its current operations. All growth to date has been funded from internally generated profits. The company is current in its payables. Revenues for the first quarter of 1999 annualized are running 34% ahead of the prior year.
- 3. All leases and capital equipment commitments of Internet Access and Web Services of Florida, Inc. are current. The company does not foresee any problems meeting future payments under these commitments.

Further, I am aware that, pursuant to Chapter 837.06, Florida Statutes, "Whoever knowingly makes a false statement in writing with the intent to mislead a public servant in the performance of his official duty shall be guilty of a misdemeanor of the second degree, punishable as provided in s. 775.082 and s. 775.083."


