COMES NOW e.spire Communications, Inc., together with its above-named subsidiaries (collectively "e.spire"), through undersigned counsel, and withdraws its Petition for Arbitration, stating as grounds the following:

- On November 25, 1998, e.spire filed a Petition for Arbitration with the Commission under Section 252 of the Federal Telecommunications Act of 1996, 47 U.S.C. Section 252, seeking arbitration of certain unresolved issues relating to its replacement interconnection agreement with BellSouth Telecommunications, Inc. ("BellSouth").
- On April 19, 1999, e.spire and BellSouth (the "Parties") entered into an agreement settling arbitration proceedings in the states of Alabama, Florida, Georgia, Kentucky, Louisiana, Mississippi, South Carolina and Tennessee.
- The agreement is embodied as the Fourth Amendment to the Parties' Interconnection
 Agreement dated July 25, 1996, as amended, and was filed with the Florida Public Service
 Commission on May 11, 1999. Approval of the Amendment is pending in Docket No. 990614-TP
- The Fourth Amendment provides, inter alia, for the extension of the Parties'
 Interconnection Agreement as amended and cited above from September 1, 1996 to December 31.
