CASE BACKGROUND

- 08/02/91 - Moreno Enterprise, Inc. obtained PATS Certificate No. 2781.
- 01/29/99 - The company mailed its 1998 RAF form and payment and requested voluntary cancellation of its certificate with an effective date of 8/1/98.
- 04/21/99 - Order No. PSC-99-0772-FOF-TC was issued, which granted the company's request for cancellation of its certificate.
- 04/26/99 - Mr. Fernando Calsvera, President, called staff and advised that his accountant had written the note on the RAF form requesting cancellation of his certificate due to a misunderstanding between them.

DISCUSSION OF ISSUES

ISSUE 1: Should the Commission reinstate Moreno Enterprise, Inc.'s PATS Certificate No. 2781?

RECOMMENDATION: Yes, staff believes that Moreno Enterprise, Inc.'s Certificate No. 2781 should be reinstated. (Isler)

STAFF ANALYSIS: After Order No. PSC-99-0772-FOF-TC was issued on April 21, 1999, Mr. Fernando Calsvera, President, called staff and advised that his accountant had, due to a misunderstanding between them, requested cancellation of Moreno's certificate. He followed up his conversation with a letter, which requested reinstatement of his certificate.

Since the company's regulatory assessment fees are paid in full, and because his accountant requested the voluntary cancellation in error, staff believes that Moreno's Certificate No. 2781 should be reinstated.
