FLORIDA WATER SERVICES CORPORATION'S  
SUPPLEMENT TO SETTLEMENT PROGRESS REPORT

COMES NOW, Florida Water Services Corporation ("Florida Water"), by and through its undersigned counsel, hereby submits this Second Settlement Progress Report as required by Order No. PSC-99-0973-WS, issued May 13, 1999, and state as follows:

1. The referenced order required Florida Water to report back to the Commission within forty-five (45) days of Florida Water's progress in achieving a settlement in this matter.

2. Over the last several months, Florida Water and Lake Suzy Utilities, Inc. ("Lake Suzy") have exchanged a significant amount of information pertinent to the settlement principles proposed, and at the end of March, Florida Water provided Lake Suzy a draft agreement for its review and comment.

3. On April 8, 1999, Lake Suzy filed a Settlement Progress Report, which Florida Water now supplements.

4. Florida Water engaged in good faith negotiations with Lake Suzy, but had been unable

to reach any settlement with Lake Suzy.

5. Upon information from counsel representing Aqua Source Utility, Inc. ("Aqua Source"), Lake Suzy has been acquired by Aqua Source.

4. At this time, the Commission may want to consider rescheduling hearings in this matter as Lake Suzy previously suggested. However, Florida Water believes more discovery will be needed and the Prehearing Order, all issues and positions stated therein, will need to be revisited in light of Lake Suzy's acquisition.

WHEREFORE, Florida Water Services Corporation suggests that if the Commission issues an Order rescheduling this matter for hearing, it also schedule a new prehearing and prehearing order and allow sufficient time to permit additional discovery.
