ORDER ACKNOWLEDGING NAME CHANGE

BY THE COMMISSION:

By letter dated May 28, 1999, Evercom Systems, Inc., holder of Interexchange Telecommunications Certificate of Public Convenience and Necessity No. 3123, requested that Certificate No. 3123 be amended to reflect the inclusion of a fictitious name, Evercom Systems, Inc. d/b/a Correctional Billing Services. Upon review of the Department of State, Division of Corporations' records, it appears that Evercom Systems, Inc. has properly registered the fictitious name. Accordingly, we find it appropriate to amend Certificate No. 3123 to reflect the new operating name.

This Order will serve as Evercom Systems, Inc. d/b/a Correctional Billing Services' amended Interexchange Telecommunications Certificate of Public Convenience and Necessity No. 3123. Evercom Systems, Inc. d/b/a Correctional Billing Services should retain this Order as evidence of the name change.



Any party adversely affected by the Commission's final action in this matter may request: 1) reconsideration of the decision by filing a motion for reconsideration with the Director, Division of Records and Reporting, 2540 Shumard Oak Boulevard, Tallahassee, Florida 32399-0850, within fifteen (15) days of the issuance of this order in the form prescribed by Rule 25-22.060, Florida Administrative Code; or 2) judicial review by the Florida Supreme Court in the case of an electric, gas or telephone utility or the First District Court of Appeal in the case of a water and/or wastewater utility by filing a notice of appeal with the Director, Division of Records and reporting and filing a copy of the notice of appeal and the filing fee with the appropriate court. This filing must be completed within thirty (30) days after the issuance of this order, pursuant to Rule 9.110, Florida Rules of Appellate Procedure. The notice of appeal must be in the form specified in Rule 9.900(a), Florida Rules of Appellate Procedure.
