- 1. <u>Notice to Customers</u>. Pursuant to Rule 25-30.030(6), F.A.C., no sooner than 21 days before the application is filed and no later than 7 days after the application is filed, the utility shall also provide a copy of the Notice, by regular mail or personal service, to each customer, of the system to be certificated, transferred, acquired, or deleted. Also, please note that to date we have not received the required affidavit and attachment regarding this corrected notice being mailed or hand delivered to the customers nor have we received the required affidavit and attachment regarding the publication of the corrected notice. Remember that the actual date the notice was issued to the customers and published in the newspaper is the date to appear in the notice. This information must be submitted to complete the noticing requirements of the application process.

Knowing that Keen Sales, Rentals and Utilities, Inc., is a small utility and relatively new to the state regulatory process, my staff have been very lenient with you concerning your meeting the requirements of utility transfers in a timely manner. However, I must remind you that pursuant to 367.071(1), Florida Statutes, no utility shall sell, purchase or modify its certificate of authorization without the **prior** approval of the Commission. In addition, I must remind you that pursuant to Section 367.161(1), Florida Statutes, if a utility willfully violates or knowingly refuses to comply with this chapter, penalties may be imposed. Therefore, I would suggest that to avoid a possible staff recommendation of show cause in this and future dockets, that you and your staff become more mindful of the requirements of utilities under the PSC jurisdiction and become more attentive to details in meeting the requirements of your utilities' dockets.
