refused to provide such payment.

4) Undersigned counsel, Alan Harrison Brents, has spoken today with Donald Clarick of Capital Services and been informed that Capital Services will not oppose Katz Kutter's motion to withdraw.

5) Withdrawal of Katz Kutter as counsel for Capital Services in this action will not prejudice Capital Services and will not prejudice any other party to this action, beyond a brief delay for Capital Services to obtain substitute counsel in this matter.

WHEREFORE, Katz Kutter respectfully requests the entry of an order allowing Katz Kutter to withdraw from representation of Capital Services in the above-styled action, and providing Capital Services with a reasonable time in which to obtain substitute counsel and for that substitute counsel to enter an appearance on behalf of Capital Services.
