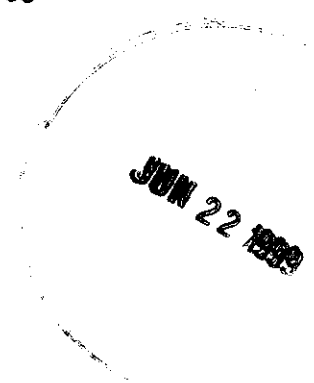

The Commission received your letter on May 7, 1999, in which you requested cancellation of your certificate with an effective date of May 31, 1999. According to the Commission's Division of Administration's records, the 1998 RAFs were due by February 1, 1999. Your payment was postmarked on February 4, 1999, which means it was paid after the due date. A balance of \$19.11 is now past due and is comprised of a \$15.93 penalty and \$3.19 interest. In addition, the 1999 RAFs will become due January 31, 2000.

The past due amount of \$19.11 must be paid in full before the certificate can be voluntarily canceled. Also, if you wish, you can go ahead and pay the 1999 RAFs on a voluntary basis, although payment is not due until January 31, 2000. Payment should be mailed to:

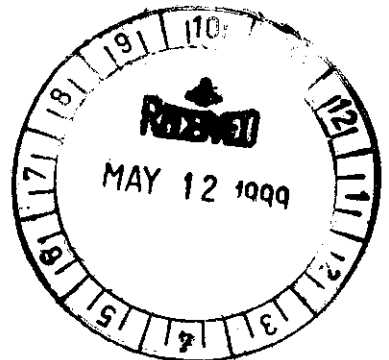

This is to request a voluntary cancellation of the Alternative Local Exchange Carrier (ALEC) certificate of "!INTERPRISE-Continental Fiber Technologies dba AlterNet Data Communications (!INTERPRISE-Continental), within the State of Florida. !INTERPRISE-Continental is a 50/50 partnership between U S WEST Interprise America, Inc. and Continental Fiber Technologies dba AlterNet (now Media1) which is being dissolved. There will be no customer impact as all existing customers' contracts will be honored and they will continue to be served in the same manner by one of the partners. Each of the partners currently holds its own individual ALEC certification from the Commission.
