## ORDER REINSTATING PAY TELEPHONE CERTIFICATE

BY THE COMMISSION:

Moreno Enterprise, Inc. (Moreno Enterprise) held Certificate of Public Convenience and Necessity No. 2781, issued by the Commission on August 2, 1991, authorizing the provision of pay phone (PATS) service.

On January 29, 1999, we received Moreno Enterprise's 1998 regulatory assessment fee form and payment, and a request for cancellation of its certificate with an effective date of August 1, 1998. By Order No. PSC-99-0772-FOF-TC, issued on April 21, 1999, we canceled PATS Certificate No. 2781.

Subsequently, on April 26, 1999, Mr. Fernando Calsvera (Mr. Calsvera), President of Moreno Enterprises, contacted our staff and advised that the request for cancellation of the certificate was made in error due to a misunderstanding. Mr. Calsvera followed up his conversation with our staff with a letter requesting the reinstatement of the certificate.

Records and Reporting, 2540 Shumard Oak Boulevard, Tallahassee, Florida 32399-0850, within fifteen (15) days of the issuance of this order in the form prescribed by Rule 25-22.060, Florida Administrative Code; or 2) judicial review by the Florida Supreme Court in the case of an electric, gas or telephone utility or the First District Court of Appeal in the case of a water and/or wastewater utility by filing a notice of appeal with the Director, Division of Records and Reporting and filing a copy of the notice of appeal and the filing fee with the appropriate court. This filing must be completed within thirty (30) days after the issuance of this order, pursuant to Rule 9.110, Florida Rules of Appellate Procedure. The notice of appeal must be in the form specified in Rule 9.900(a), Florida Rules of Appellate Procedure.
