On March 12, 1999, this Commission issued Proposed Agency Action (PAA) Order No. PSC-99-0513-FOF-WS, approving increased rates and charges for United Water Florida, Inc. (UWF). On April 2, 1999, the Office of Public Counsel (OPC) protested the PAA Order and filed a petition for a formal hearing. On May 4, 1999, the parties filed a settlement stipulation and withdrawal of OPC's protest. On May 25, 1999, this Commission issued Order No. PSC-99-1070-FOF-WS, approving the parties' settlement and consummating PAA Order No. PSC-99-0513-FOF-WS.

Order No. PSC-99-1070-FOF-WS, contained schedules from the original PAA Order, which were referred to as "Revised Schedules." Revised Schedule No. 5 set forth UWF's allowance for funds prudently invested. However, when Order No. PSC-99-1070-FOF-WS was issued, an erroneous revised schedule was substituted for the original Schedule No. 5. Accordingly, Order No. PSC-99-1070-FOF-WS is amended to include the correct Revised Schedule No. 5. Order No. PSC-99-1070-FOF-WS is reaffirmed in all other respects.

Based on the foregoing, it is

ORDERED by the Florida Public Service Commission that Order No. PSC-99-1070-FOF-WS is hereby amended as set forth in this Order. It is further

ORDERED that Revised Schedule No. 5 is incorporated herein by reference. It is further
