

Case No. 99-31527 (WFT) was filed on February 10, 1999, in the US Bankruptcy Court of the District of New Jersey. On June 24th, the Court approved the sale of substantially all of Telegroup's assets to Primus Telecommunications, Inc. That transaction was consummated on June 30, 1999. Consequently, Telegroup, Inc. is no longer conducting any business in your state.
