BellSouth Telecommunications, Inc. ("BellSouth" or "Company") hereby files, pursuant to Rule 25-22.006, Florida Administrative Code, its Request for Specified Confidential Classification for the audit workpapers in connection with the Complaint of ATNEX Computer Corp. ("ATNEX"); Docket No. 990193-TP; Audit Control No. 99-126-4-1.

1. In a letter dated June 28, 1999, and a letter dated July 9, 1999, the Florida Public Service Commission ("the Commission"), notified BellSouth that it had concluded its fieldwork in the above audit. The audit workpapers contain confidential business information. This information is competitively sensitive and customer specific.
