





PRICE LIST FORMAT SHEETS

- A. **Sheet Numbering** - Sheet numbers appear in the upper right corner of the page. Sheets are numbered sequentially. However, new sheets are occasionally added to the price list. When a new sheet is added between sheets already in effect, a decimal is added. For example, a new sheet added between sheets 14 and 15 would be 14.1.
- B. **Sheet Revision Numbers** - Revision numbers also appear in the upper right corner of each page. These numbers are used to determine the most current sheet version on file with the FPSC. For example, the 4th revised sheet 14 cancels the 3rd revised sheet 14. Because of various suspension periods, deferrals, etc., the FPSC follows in their price list approval process, the most current sheet number on file with the Commission is not always the price list page in effect. Consult the Check Sheet for the sheet currently in effect.
- C. **Paragraph Numbering Sequence** - There are nine levels of paragraph coding. Each level of coding is subservient to its next higher level:


PRICE LIST FORMAT SHEETS

- D. Check Sheets - When a price list filing is made with the FPSC, an updated check sheet accompanies the prices list filing. The check sheet lists the sheets contained in the price list, with a cross reference to the current revision number. When new pages are added, the check sheet is changed to reflect the revision. All revisions made in a given filing are designated by an asterisk (*). There will be no other symbols used on this page if these are the only changes made to it (i.e., the format, etc. remains the same, just revised revision levels on some pages). The price list user should refer t the latest check sheet to find out if a particular sheet is the most current on file with the FPSC.



- 1.1 Access Line - An arrangement which connects the customer's location to a JTC Communications, Inc. network switching center.
- 1.2 Company or Carrier - JTC Telecommunications, Inc.
- 1.3 Customer - the person, firm, corporation or other entity which orders service and is responsible for payment of charges due and compliance with the Company's price list regulations.
- 1.4 Holidays - JTC Communications, Inc.'s recognized holidays are New Year's Day, Memorial Day, July 4th, Labor Day, Thanksgiving Day, and Christmas Day. Offices closed, no interruption of service.

SECTION 2 - RULES, REGULATIONS AND SERVICE QUALITY CRITERIA

2.1

- 2.1.1 **Service Availability** - The entire calling area of Florida to provide local exchange service.
- 2.1.2 **Interruption of Service** - Service may be suspended if the account is not paid in full by the bill due date. There will be a ten (10) day written notice of service termination.
- 2.1.3 **Service Restoration** - Suspended service may be restored by paying a restoration fee, along with the past due amount on the account paid in full.
- 2.1.4 **Disconnection** - If the restoration fee and past due account balance is not paid in full within ten (10) days of the notice of terminated service date, the account will be disconnected.
- 2.1.5 **Re-connection** - If an account has been disconnected, reconnection can be obtained by paying the past due amount, in full, on the account and paying the new account connection fee in the amount of Forty (\$40.00) Dollars.
- 2.1.6 **Deposits and Advance Payments** - No deposits are required. All accounts are prepaid thirty (30) days in advance. (Payments can only be made in the form of money order or cashier's checks. No personal checks accepted.)
- 2.1.7 **Limitations** - Local Prepaid Phone Service Only. This does not include an extended local calling area, long distance or collect calls. In the event we are unable to block these calls, the customer is responsible for any and all charges incurred.

2.1 (continued)

- 2.1.8 **Liabilities of the Company** - The Company and or its dealers will be held "harmless" against claims or damages that arise from accidental disconnect, including but not limited to any inability to access 911.
- 2.1.9 **Billing Periods** - Payment is prepaid 30 days in advance and will begin on the actual date of connection.
- 2.1.10 **Refunds/Credits** - A request for a refund or credit, for whatever the reason, must be made in writing by the customer and mailed to: JTC Communications, Inc., Louisville, Kentucky, 40202. The request for the refund will be reviewed and the customer will either receive a credit, or an explanation as to why no credit is due. This notification will be given to the customer within 30 days of receipt of the actual request.
