Dear Pat:

I'm enclosing tariff sheets Original Sheet 16.0 and Original Sheet 19.0 for CHC VII, Ltd. and Four Lakes Golf Club, Ltd.

According to Mr. Raymond Moats, Anglers Cove West, Ltd. <u>can not</u> modify tariff sheets Original Sheet No. 27.2 and Original Sheet No. 27.6, and Hidden Cove, Ltd. <u>can not</u> modify tariff sheet Original Sheet No. 25.1. Anglers Cove West and Hidden Cove can not change their applications, because these applications reflect the authorized language of the Bureau of Mobile Homes as approved in each prospectus.

To modify the language in these applications would require amending the prospectus for each park. Amending each prospectus would require a filing fee of \$10.00 per lot, as well as the cost of engaging attorneys to prepare and file each prospectus with the Bureau of Mobile Homes. Imposition of this cost would create a substantial hardship for Anglers Cove West, Ltd. and Hidden Cove, Ltd.

Anglers Cove West, Ltd. and Hidden Cove, Ltd. will charge only the flat rate authorized by the Commission, and will not change their rate without prior approval of the Commission.
