ORDER REINSTATING PAY TELEPHONE CERTIFICATE

BY THE COMMISSION:

FKI Enterprises, Inc. (FKI Enterprises) currently holds
Certificate of Public Convenience and Necessity No. 4542, issued by
the Commission on March 19, 1996, authorizing the provision of pay
phone service (PATS).

On January 20, 1999, we received FKI Enterprises' 1998
Regulatory Assessment Fees (RAFs) form with a note from FKI
Enterprises requesting the cancellation of its certificate. The
company made a 1998 RAF minimum payment of \$50 on March 30, 1999.
Therefore, Order No. PSC-99-99-0867-FOF-TC was issued to grant the
company's request for cancellation of its certificate.

However, on May 7, 1999, we received a letter, dated May 3,
1999, from Mr. D. K. Stimson Jr., requesting reconsideration on the
Order cancelling FKI Enterprises certificate. He further explained
that due to medical reasons, he had been unable to pay the RAFs in
a timely manner and he did not want the company's certificate to be
cancelled. Our staff communicated to Mr. Stimson, via letter, that
the certificate had been cancelled upon his request. Subsequently,
Mr. Stimson contacted our staff and advised that there had been a
misunderstanding and that he would like the company's certificate
reinstated.



Any party adversely affected by the Commission's final action in this matter may request: 1) reconsideration of the decision by filing a motion for reconsideration with the Director, Division of Records and Reporting, 2540 Shumard Oak Boulevard, Tallahassee, Florida 32399-0850, within fifteen (15) days of the issuance of this order in the form prescribed by Rule 25-22.060, Florida Administrative Code; or 2) judicial review by the Florida Supreme Court in the case of an electric, gas or telephone utility or the First District Court of Appeal in the case of a water and/or wastewater utility by filing a notice of appeal with the Director, Division of Records and reporting and filing a copy of the notice of appeal and the filing fee with the appropriate court. This filing must be completed within thirty (30) days after the issuance of this order, pursuant to Rule 9.110, Florida Rules of Appellate Procedure. The notice of appeal must be in the form specified in Rule 9.900(a), Florida Rules of Appellate Procedure.
