BY THE COMMISSION:

By letter dated December 1, 1998, Electric Lightwave, Inc. (Electric Lightwave), Citizens Telecommunications Company d/b/a Citizens Communications Company (Citizens Communications), Citizens Utilities Company (Citizens Utilities), and Citizens Newco Company (Citizens Newco) requested approval of a transfer of stock of Citizens Communications and Electric Lightwave from Citizens Utilities to Citizens Newco. By Order No. PSC-99-0251-FOF-TI, issued February 9, 1999, we approved the transfer.

On June 11, 1999, the companies informed the Commission that the transaction did not take place. Since the transfer of stock did not take place, we find it appropriate to vacate Order No. PSC-99-0251-FOF-TI.



Any party adversely affected by the Commission's final action in this matter may request: 1) reconsideration of the decision by filing a motion for reconsideration with the Director, Division of Records and Reporting, 2540 Shumard Oak Boulevard, Tallahassee, Florida 32399-0850, within fifteen (15) days of the issuance of this order in the form prescribed by Rule 25-22.060, Florida Administrative Code; or 2) judicial review by the Florida Supreme
