On behalf of Sprint Payphone Services, Inc. (SPSI), enclosed please find this request for waiver of Rule 25-24.515¹³(8), F.A.C. for filing in the above captioned matter.

SPSI requests that the pay telephones located at the addresses below be exempted from the provisions of Rule 25-24.515¹³(8), Florida Administrative Code, which requires that all pay telephone stations must allow incoming calls to be received "with the exception of those located at penal institutions, hospitals and schools and at locations specifically exempted by the Commission."
