Re: Docket No. 990940-WS; Application of Aloha Utilities, Inc. for Amendment of Water and Wastewater Certificates Nos. 570-W and 496-S in Pasco County.

Dear Ms. Dutra and Mr. Jenkins:

After reviewing the application in the above referenced docket, the staff has identified the following deficiencies. Please correct and/or provide additional information as requested.

1. As required by Rule 25-30.036(3)(j), Florida Administrative Code, the utility must provide a statement describing the capacity of the existing lines, the capacity of the treatment facilities and the design of the proposed extension. The utility's response appears to be adequate for the lines. Please provide the capacity of the water plant, current flows at the water and wastewater plants and projected water and wastewater flows from the additional area.

2. As required by Chapter 367.045(2)(b), Florida Statutes, the applicant must provide information on the need or lack of need for service in the area. Although the application indicates there is a need for service, no time frame was provided. Please advise when service will be needed _____ (months or years).

3. As required by Rule 25-30.036(3)(f), Florida Administrative Code, the utility must provide one copy of a detailed system map showing the proposed lines, treatment facilities, and the territory proposed to be served. The map shall be of sufficient scale and detail to enable correlation with the description of the territory. Although a map was provided, no lines or treatment facility were on the map. Please resubmit.

4. As required by Rule 25-30.036(3)(l), Florida Administrative Code, the utility "must provide a detailed statement regarding the proposed method of financing the construction...." Please submit.



In staffs' informal meeting on July 31, 1999 it was discussed that Aloha may have over-paid by submitting \$4,500 in filing fees. Please provide a breakdown in Equivalent Residential Connections (ERC's) of the additional water and wastewater customers to be added along with the water and wastewater customers that are being deleted. Please provide a detailed calculation on how you obtained the filing fees. As we discussed, the utility must file a request for a refund of filing fees if you believe such a refund is warranted.

Please file an original and five copies of the requested information no later than August 25, 1999 with the Director, Division of Records and Reporting, 2540 Shumard Oak Boulevard, Tallahassee, FL 32399.
