

REQUEST SPECIFIED CONFIDENTIAL CLASSIFICATION**

BellSouth Telecommunications, Inc. ("BellSouth" or "Company") hereby files, pursuant to Rule 25-22.006, Florida Administrative Code, its Notice of Intent to Request Specified Confidential Classification for the Data Request on local exchange competition in Florida.

1. In a letter dated July 1, 1999, the Florida Public Service Commission ("Commission"), requested BellSouth to report on the development of local exchange competition in Florida. This is being done in order to prepare and deliver an annual report on the status of competition in the telecommunications industry to the Governor and the Legislature. The information BellSouth is providing is customer specific.
