AMENDED EXHIBIT "D"

Premiere Network Services, Inc. ("Premiere") is technically qualified to provide local exchange services in Florida. In addition, in order to implement its Designer Carrier strategy, Premiere will also provision UNEs or "smart builds."

Premiere Network Services, Inc. intends to initially rely on providers currently certified by the Florida Public Service Commission as underlying carriers to provide local exchange service, local telecommunications service and switched access service.

Premiere plans to provide additional value-added options to its clients by not only being in a position to *specify* telecommunications enhancements which embrace emerging technologies but to actively *implement* them for our clients.

- I. We anticipate the scope of services will include, but not be limited to:
 - \geq OC-12 SONET Access Facilities
 - Asynchronous Transfer Mode Services (ATM)
 - ISDN/ADSL Services
 - T1/T3 Services, also including T1/T3 upgrades to SONET OC-XX
 - Integrated Wide Area Network Management Systems
 - Fault-Tolerant Network Assemblies for Disaster Recovery (like SWB Secure-Net)

- II We also anticipate offering services aimed at the following applications, utilizing a variety of Custom Network Services and Delivery System for:
 - Native LAN Connectivity
 - Supporting Business Resumption Centers
 - Televaulting and Remote Data Archiving
 - Teleradiology and Medical Applications
 - Education
 - Remote Serving Applications

- III Lastly, in order to provide a complete range of services, we also plan to provide, but not necessarily concentrate on, the following traditional services:
 - Local exchange and extended area service, toll restriction, call control options, touch tone, caller ID service, and any other services available on a resale basis from the underlying local

exchange carrier or other certified carrier within the service area of Premiere.

Because Premiere will offer underlying services of incumbent LECs, it will rely on the incumbent LECs to provide access to 911 emergency service. Premiere is familiar, and will comply, with all rules and regulations of the Commission pertaining to 911 services and will ensure that 911 services will be readily accessible to its customers in Florida in cases where it builds its own facilities.
