By letter dated March 18, 1998, IDT Corporation (IDT) and IDT America Corp. (IDT America) jointly requested approval of IDT's pro forma corporate reorganization and assignment of its Interexchange Telecommunications (IXC) Certificate No. 3581 to its wholly-owned subsidiary, IDT America. IDT has stated that the transactions will be virtually transparent to its customers.

We determine that IDT has met the requirements of Section 364.33, Florida Statutes. Accordingly, we find that the reorganization is in the public interest, and we approve it pursuant to Section 364.33, Florida Statutes.
