Dear Mr. Fisher:

On August 16, 1999, we received your correspondence addressing concerns about Crooked Lake Park Sewerage company's proposed rate increase. Your correspondence will be placed in the docket file and your concerns will be addressed in staff's recommendation.

Staff's recommendation addressing the case is tentatively scheduled to be filed with Records and Reporting on September 23, 1999, for the Commission's review. The Commission is tentatively scheduled to consider and vote on staff's recommendation at the October 5, 1999 Agenda Conference. The Agenda will be held at the Capital Circle Office Center, 2540 Shumard Oak Boulevard, Easley Building, Room 148, Tallahassee, Florida. The Agenda will begin at 9:30 a.m., but due to the number of items to be considered, I cannot say exactly when your item will be considered. If you wish to attend, please arrive promptly at the beginning of the Agenda Conference. Any interested party is welcome to attend this Agenda Conference and may observe or participate in the discussion of this item.

In your letter you indicated that you are protesting the utility's proposed rate increase. A protest at this time is premature. After the Commission makes a decision, a Proposed Agency Action (PAA) order will be issued within 20 days. Customers will have 21 days from the date the Order is issued to file a protest. If you wish to protest the PAA Order, you may submit a petition to the Division of Records and Reporting stating which issues you specifically protest and whether you are requesting a hearing.


