Dear Ms. Bayor:

By this letter, Arch Communications Group, Inc., Arch Communications, Inc., Arch Paging, Inc., and their subsidiary Arch Southeast Communications, Inc. (collectively, "Arch") inform the Florida Public Service Commission that on December 31, 1998, the Arch subsidiary Arch Southeast Communications, Inc., which owned and operated radio paging systems in Florida, was merged into its affiliate, Arch Communications Enterprises, LLC, which is also an indirect, wholly-owned subsidiary of Arch with Arch Communications Enterprises, LLC as the surviving entity. Upon review of Florida statutes and consultation with Commission staff, we understand that Commission approval of this *pro forma* merger was not required. As a result of this *pro forma* reorganization, paging services formerly provided by Arch Southeast Communications, Inc. are now being provided by Arch Communications Enterprises, LLC. In addition, on June 3, 1999, MobileMedia Communications, Inc. merged with a subsidiary of Arch Communications Group, Inc., with the Arch subsidiary as the surviving company.
