ORDER ACKNOWLEDGING NAME CHANGE

BY THE COMMISSION:

By letter dated July 22, 1999, Zero Plus Dialing, Inc. d/b/a U.S. Billing, holder of Interexchange Telecommunications Certificate of Public Convenience and Necessity No. 3987, requested that Certificate No. 3987 be amended to reflect the new corporate name, Billing Concepts of Florida, Inc. d/b/a USBI, d/b/a ZPDI, and Zero Plus Dialing. Upon review of the Department of State, Division of Corporations' records, it appears that Zero Plus Dialing, Inc. d/b/a U.S. Billing has properly registered the new corporate name. Accordingly, we find it appropriate to amend Certificate No. 3987 to reflect the new corporate name.

This Order will serve as the amended Interexchange Telecommunications Certificate of Public Convenience and Necessity No. 3987 for Billing Concepts of Florida, Inc. d/b/a USBI, d/b/a ZPDI, and Zero Plus Dialing. Billing Concepts of Florida, Inc. d/b/a USBI, d/b/a ZPDI, and Zero Plus Dialing should retain this Order as evidence of the name change.

ORDERED by the Florida Public Service Commission that the request by Zero Plus Dialing, Inc. d/b/a U.S. Billing to change the name on Certificate No. 3987 from Zero Plus Dialing, Inc. d/b/a U.S. Billing to Billing Concepts of Florida, Inc. d/b/a USBI, d/b/a ZPDI, and d/b/a Zero Plus Dialing is hereby approved. 

This notice should not be construed to mean all requests for an administrative hearing or judicial review will be granted or result in the relief sought.

Any party adversely affected by the Commission's final action in this matter may request: 1) reconsideration of the decision by filing a motion for reconsideration with the Director, Division of Records and Reporting, 2540 Shumard Oak Boulevard, Tallahassee, Florida 32399-0850, within fifteen (15) days of the issuance of this order in the form prescribed by Rule 25-22.060, Florida Administrative Code; or 2) judicial review by the Florida Supreme Court in the case of an electric, gas or telephone utility or the

This filing must be completed within thirty (30) days after the issuance of this order, pursuant to Rule 9.110, Florida Rules of Appellate Procedure. The notice of appeal must be in the form specified in Rule 9.900(a), Florida Rules of Appellate Procedure.
